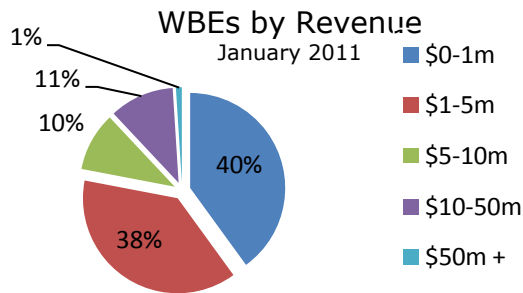

There are 500+ WBENC certified women owned businesses in Astra's region. The average WBE business has 30 employees, has been in business 10 years and has gross revenues of \$8,000,000. Over 60% of WBEs have revenues in excess of \$1 million. The largest WBE has revenues in excess of \$1.2 billion.
